



During the Annual Indiana Patient Safety Summit, approximately 150 to 200 patient safety and quality leaders come together to learn effective strategies and share best practices that will improve patient safety statewide. From CEOs and CNOs to nursing caregivers, case managers and pharmacists, anyone responsible for patient safety and leading change for improvement will engage with one another through this informative and inspiring experience.

#### IHA Annual Meeting – November 13-14, 2024, at The Westin Indianapolis


